

FAQs and General Information

Please review our Calendar located online for an idea of available dates for your function.

(We update at the end of every month)

- The area of Beach on the West End of Ocean Isle is tide sensitive, so please plan as close to low tide as possible. (Tides are constantly changing and you will need a tide table)
- We have plenty of parking for all sizes of parties.
- Due to North Carolina Health regulation we are not permitted to send any food or beverage home with you after a buffet event.
- Due to North Carolina ABC regulations we are not permitted to allow you to bring in any alcoholic beverages other than wine, in which there is a \$10 per bottle corkage fee.
- You will have access to the room, or the restaurant if having a facility buy out, to decorate at 11:30am. (In some cases we can allow you access to the room the night before if another event is not scheduled and we have the ability.
- It is our desire to have a completed menu and full information for events 1 month before the date.
- North Carolina Sales tax is 6.75%
- Our Service charge/gratuity policy for food and beverage is 20%
- We need a final head count for events 1 week before your event, with the ability to alter the number up to 72 hours ahead of time.
- Your room fee and deposit (one in the same) are non-refundable, however, if you need to reschedule your event to another date, as long as we have an opening for your new date, that will not be a problem.
- We have dressing areas available in our locker rooms attached to the restrooms with access to the beach.
- If you have any chronological order of events made with your D.J./Wedding Planner/Family member please make sure we get a copy.
- You will be responsible for payment for your food portion of your event 2 weeks prior to the event.

(In some cases there is a set bar bill, that must be paid as well 2 weeks before)

This may be in the form of personal check, credit card, business check, cash, or money order.

WE DO NOT ACCEPT PERSONAL CHECK FOR THE REMAINDER OF THE BILL PAID THE NIGHT OF.

- We will provide all tables (Round or Rectangle), chairs, white linens, cutlery, glassware, cake table, gift table, ect. that you will need for your function, this is what your room fee is for.
- Please review our menu for prices for food. Please review our bar information page for the options we offer for setting up the bar.
- We reserve the right to stop serving alcohol, and possibly ask to leave the premises, to any inebriated party members that cannot conduct themselves in a mature and responsible manner.

- The four hours allotted to the room rental is for “party time” only and does not include any setup or decorating time.
- All parties must end by 11:30pm.
- Your cake supplier may arrive anytime the day before or day of to setup the cake or give to us for keeping.
- If you are utilizing a professional wedding coordinator or planner we would like a chance to speak with or possible meet them before hand. The Isles Restaurant and management staff considers the bride/groom as our client, not the planner or coordinator. It is their wishes and desires that we want to meet with the strictest standards of quality and excellence. That being said, we do understand the important abilities that planners and coordinators bring to an event, and will work closely with them to provide a memorable celebration.
